

## SYNTHOMER PRIZE DRAW TERMS AND CONDITIONS

14.03.2019



1. Synthomer Deutschland GmbH (hereinafter "The Promoter") will carry out a promotion during the European Coatings Show 2019 in Nuremberg, Germany (hereinafter referred to as "ECS") in the form of three prize draws ("The Promotion").
2. Each prize draw is open to all visitors of the ECS aged 18 years or over, except employees of the Promoter, their families, agents or any third party directly associated with the administration of the prize draws.
3. The prize draws are free to enter and no purchase is necessary.  
To enter the prize draws, entrants must carry out the following entry method:  
Via the entrant's personal LinkedIn account publicly post a photograph of the entrant visibly being located at the Promoter's booth number 344 in hall 7 of the ECS (hereinafter referred to as "Promoter's Booth" and "Booth of the Promoter") alongside the Synthomer logo together with the hashtag #SynthomeratECS.
4. Only one entry is allowed per participant and multiple entries will not be included in the prize draws.
5. The opening date for entries to the prize draws is Tuesday March 19th 2019. The closing date for entries to the prize draws is Thursday March 21<sup>st</sup> 2019 at 16.00 CET (entries after Thursday March 21<sup>st</sup> 2019 at 16:59 CET will not be included in the prize draw). On each day of the ECS (19.03.2019; 20.03.2019; 21.03.2019) a prize draw will take place at 17.00 CET (entries after the prize draw of such day will not be included in this respective prize draw).
6. An entrant will be accepted to each prize draw taking place on or after its entrance, provided the timelines provided in these terms and conditions have been met.
7. The Promoter accepts no responsibility for entries not successfully completed due to a technical fault (including but not limited to technical malfunction, computer hardware or software failure, satellite, network or server failure) of any kind.
8. The winners for each respective prize draw shall be selected randomly by the Promoter from the list of entrants. The outcome of each selection of winner within a prize draw is final.
9. The prize to win for each prize draw is an Amazon Echo device (speaker and voice assistant) (the "Prize").
10. Each winner will be announced by means of a post on the Promoter's LinkedIn page and must approach the Promoter's Booth to claim his/her prize within the time specified in the LinkedIn post. If a winner does not claim the prize within the time specified in the post, then the winner's prize will be forfeited and the Promoter will be entitled but shall not be obliged to select another winner from the remaining entries in the same manner as detailed above. Any winner whose prize has been forfeited shall not be eligible to participate in any subsequent prize draws.
11. The prizes will be handed to the winners in person at the Promoter's Booth where each winner agrees to having its picture taken alongside staff of the Promoter. These photos will be posted to the Promoter's LinkedIn account linked to the winner's profile.
12. The prizes for the winners are non-exchangeable, non-transferable and no cash alternative is offered.

13. The decision of the Promoter regarding any aspect of each prize draw is final and binding and no correspondence will be entered into about it.
14. Participants are deemed to have accepted and agreed to be bound by these terms and conditions upon entry. The Promoter reserves the right to refuse entry or refuse to award the prizes to anyone in breach of these terms and conditions.
15. The Promoter reserves the right to hold void, cancel, suspend, or amend the promotion where it becomes necessary to do so.
16. Entries considered by Promoter to have been submitted in an unsportsmanlike manner and/or contain offensive or harmful content, will not be included in any prize draws. By way of an example only, anyone found to have created multiple LinkedIn accounts in order to increase their chances of winning will be disqualified from any prize draw under grounds of unsportsmanlike conduct. Promoter's decision in this regard is final.

The Promoter (contact details below) is responsible for the promotion and, by entering in the prize draw, each entrant agrees not to hold LinkedIn responsible for the administration and/or outcome of the prize draw.
21. This promotion and each of the prize draws will be governed by German law and participants to the prize draw submit themselves to the exclusive jurisdiction of the courts of Düsseldorf, Germany.
